Introduction

As the duty cast on the judicial officer is to look at the two sides of the coin and test its veracity and decide the case at the earliest, the transformation from an Advocate as a Judge assumes importance and for the same grooming gains significance.

Attire

Though the judicial officer is a common man and would have been in outfits of his own choice, it would be appropriate to give importance to the dressing, as it is needless to say that a good dressing would certainly give a decent look and being in an adorable and sacrosanct position, it is duty bound to take care that the image is not tarnished, to any extent, by the attire.

Be on time/Punctuality

Decorum/Discipline

Fairness

Fairness is the expectation in all areas. But, it is the spine in judiciary, as even if there is slightest tumble, everything would be futile. Fairness is to be imparted without any reservation and there can no substitute for the same and the oath taken in this aspect should always ring in our mind.

Grip in the proceedings

Presenting one's case might not be of much difficult. But, at the same time, conducting the court proceedings where the parties are at logger heads, is not an easy job. As such, it is the need to have the grip or control over the proceedings and see that there is no flaw in it. To which, much care to be taken to see that we improvise ourselves in the related area, to fasten the grip.
