C I R C U L A R.

Sub:- Nomenclature - Nomenclatures to be used in respect of cases filed under Tenancy enactments, Workmen's Compensation Act, Debt Relief Act, Land Reforms enactments and other Special enactments - Prescribed.

Ref:- High Court's Circular Roc.No.406/81.R.R. dated 5-12-1981.

In continuation of the High Court's Circular cited prescribing certain nomenclatures in respect of the proceedings filed under the Tamil Nadu Buildings (Lease and Rent Control) Act, 1960, References under section 18 or 30 of the Land Acquisition Act and petitions for compensation under the Motor Vehicles Act and with a view to secure uniformity throughout the Subordinate Judiciary in the matter of classification of proceedings instituted under the various enactments the High Court considers and directs that the following nomenclatures be adopted by all the Subordinate Courts throughout the State in respect of the proceedings mentioned against each as hereunder.


