I am to invite your attention to the above reference first cited, wherein Government have sanctioned certain items of recommendations of Shetty Commission to Judicial Officers. For item of Transfer Grant/Disturbence allowances, Government accorded sanction for composite Transfer Grant to the transferred Judicial Officers as follows.

- (a) Composite Transfer Grant equal to one months basic Pay in case of transfer involving a change of station located at a distance of more than 20km., for each other.
- (b) Incase of transfer to stations which are less than 20 Km from the old station or transfer within the same city, the composite Transfer Grant will be restricted to one third of the basic pay, provided a change of residence is actually involved.

The second

(c) Further the composite Transfer Grant Excludes incidental expenses of the transferred officers and the members of his/her family and the expenses to go from the residence to Railway Station/Bus Stand and / Airport, etc., and the expenses towards transportation of personal effect.

shall be debited to the head of account "04-Travel Expenses-02-Transfer Travelling Allowances". Therefore all Sub-Controlling Officers are instructed to book the expenditure only under the above head of account for which Budget allotment is necessary. In the reference second cited the Government have exempted this item of expenditure from the operation of Quarterly Control of Appropriation system among other items and the same has also been communicated to all Sub-Controlling Officers in the reference third cited.

It is also instructed that the Sumptuary Allowance sanctioned under Shetty Commission recommendations is being booked under the Salary head as Other Allowances. But this has to be booked under the detailed head 14-00-Sumptuary Allowances only as stated in the Government order. This instruction may kindly be taken note of while preparing bills of Judicial Officers.
