In the reference first cited, the details of the scheme for  
materialization of Tax Deducted at Source(TDS) certificates issued  
by the Director General of Income Tax (System) has been  
communicated for information and necessary action.

2. In the reference second cited, it has been pointed out  
that only 2,824 out of the 23,747 Drawing and Disbursing Officers of  
Govt. of Tamil Nadu have so far obtained Tax Deduction and  
Disbursal Number (TAN). It may be pointed out that failure to apply for  
TAN can attract a penalty of Rs.10,000/- as per the  
provisions issued by the Director General of Income Tax, Chennai.

3. I am therefore directed to request you to ensure that  
all officers under your control obtain the TAN No. immediately if they  
have not obtained so far and file quarterly TDS return as per the  
provisions contained in the reference first cited.
