Sub: Courts and Judges – Half Yearly Periodical Meeting of Judicial Magistrates with the Police Officials and Prosecuting Authorities – Guidelines contained in the Criminal Rules of Practice and Circular Orders 1958 – instructions issued for better Administration of Justice

Read: Item No.13 of "Instructions regarding the Preparation and submission of the Annual Administration Report to the High Court" – in the Criminal Rules of Practice and Circular Orders 1958

The attention of the Chief Judicial Magistrates/Chief Metropolitan Magistrate, Egmore, Chennai, is drawn to the instructions/guidelines as envisaged in Item No.13 of "Instructions regarding the Preparation and submission of the Annual Administration Report to the High Court" – in the Criminal Rules of Practice and Circular Orders 1958.

It has been brought to the notice of the High Court that the half yearly Co-ordination meeting of the Judicial Officers functioning in the Criminal Unit with the Police Officials and Prosecuting authorities are not convened periodically within the stipulated time and henceforth the reports thereof have not been received in this Registry, causing much inconvenience to the High Court

In the interest of better Administration of Justice the following instructions are issued:-

All the Chief Judicial Magistrates/Chief Metropolitan Magistrate, Egmore, Chennai, as the case may be, are strictly directed to convene the half yearly Co-ordination meeting between the Judicial Officers functioning in their respective Criminal Unit, Police Officials and the Prosecuting authorities periodically within the stipulated time without fail.

They are also directed to submit the report containing all the relevant details including the progress made thereof, steps taken, immediately to this Registry, without fail. Any deviation/non-compliance will be viewed seriously.

The receipt of this circular is to be acknowledged at once.
