

For Item 'Concurrent Charge Allowance' under paragraph 2 of the Government Order, the following shall be substituted;

CONCURRENT CHARGE ALLOWANCE

The Government sanction the Concurrent Charge Allowance to the Judicial officers when they are placed in charge of another court continuously beyond the period of ten working days and if they perform appreciable judicial work of that court, the charge allowance be paid to such Judicial officer at 10% of the minimum of the time scale of the additional post held. The other guidelines provided in Rule 49 of F.R. shall be applicable to the Judicial Officers. //pto// .
