ORDER:

The following amendments are issued to G.O.Ms.No.985 Home dated 16.10.2006.

Amendment

Under item No."2 Medical Facilities" of the above said Government order for the sub-paras 4 & 5 the following shall be substituted:-

- "4. Medicial claim / reimbursement of the Judicial Officers both serving and retired, and their family the bills relating to Chennal City be referred to the Director of Medical Education for remarks and the bills other than Chennal City be referred to the Director of Rural Health Services for remarks, prior to sanction
  - a. The Principal District Judges are authorized to sanction medical reimbursement to serving as well as retired Judicial Officers and for themselves up to Rs.50,000/- (Rupaes fifty thousand only) per case;
  - b. Powers delegated to the Hon'ble Chief Justice of Madras High Court, Chennal to sanction the medical reimbursement claim of serving and retired Judicial Officers above Rs.50,000/- (above Rupees fifty thousand only) and up to Rs.1,00,000/- (up to Rupees one lakh only) per case;
  - c. Medical reimbursement claim / Bills above Rs.1.00 lakh (above Rupees one lakh only) in respect of serving Judicial Officers and retired Judicial officers shall be sent to Government for sanction".

P.T.O

- "5 Judicial Officer both serving and retired shall be entitled to advances to meet the medical expenses for treatment up to 80% of the estimate and the balance be paid after approving the bill when it is produced. The authority to sanction the above advance are as per the delegation of powers stated in sub-para 4 (a) (b) &(c) above".
