

Ref: 1) High Court's R.O.C. letter No.47/2008-D4, Dated 22 4.09. 2) My D.O. letter No.33094/Courts-III/2009-2, Dated 5.5.09. 3) Your D.O. letter No.47/2008-D4, Dated 24.7.09. With reference to your letter cited, a meeting was hold with the Chairman, Tamil Nadu Electricity Board in this regard on 30.7:09. has since agreed to modify the hours of load shedding in respect of Subordinate Courts in order to ensure that load shedding either to take place prior to Court hours or in a few cases, he has taken action to exempt the feeder line supplying power to the Court buildings from load shedding. A detailed statement indicating the position stated by the High Court, status as indicated by the Officers of Tamil Nadu Electricity Board and the changes proposed is enclosed. It is expected that the changes proposed would be operational not later than the 10th August '09. This may be placed before the Hon'ble Chief Justice for information. I am directed to state that, based on the reports received from Subordinate Courts, regarding frequent power cuts during Court hours, both in the District and Taluk level, the Government was requested to make necessary arrangements for uninterrupted supply of power during Court hours on all working days. The Court wise details relating to interruption of supply of power continuously for an hour or more was forwarded for ready reference of the Government and the copy of the details was also forwarded to the Chairman, Tamil Nadu Electricity Board, Anna Salai.

The Government held a meeting on 30.07.2009, with the Chairman. Tame Electricity Board, who agreed to modify the hours of load shedding in respective certain Subordinate Courts in order to ensure that load shedding take place prior Court hours or to exempt the feeder line supplying power to the Court Buildings.

The Chairman, Tamil Nadu Electricity Board, has informed the High Court by ref.No.3 cited that arrangements have already been made to maintain uninterrupted power supply to the Subordinate Courts during Court functioning hours on all working days with effect from 3<sup>rd</sup> August 2009 and that the Tamil Nadu Electricity Board will ensure uninterrupted power supply to the Subordinate Courts during Court functioning hours on all working days in future.

In the above circumstances, you are requested to interact with the Electricity Department Officials, if need be, to ensure that there is no power cut during Court working hours not only in the District but also in the Taluk level, so that Court work is not nampered at all.

am to request you to state the present stage / situation prevailing with regard to the Power supply to all Courts in your jurisdiction by return of fax and henceforth submit a weekly report as to the position in your District to the High Court, to enable the High Court to take necessary remedial steps, if necessary, in the matter.
