ORDER:

The Government have issued orders sanctioning 10% additional fitment benefit on the basic pay of the Judicial Officers in the pre revised scales as on 01.01.1996, notionally with monetary benefit from 01.07.1996 in the reference 1st cited above.

2. In pursuance of the orders in the references 1st and 2nd cited, the following Judicial Officers who are functioning are sanctioned 10% additional fitment benefit on the basic pay in the pre revised scales as on 01.01.1996 notionally with monetary benefit with effect from 01.07.1996.

3. The Officers who are appointed on or after 01.07.1996, are eligible for 10% additional benefit on the basic pay in the pre revised scales from the date of assumption of charge as Civil Judges (Junior Division).

4. The Scale of Pay of Civil Judges (Junior Division) is Rs.9000-250-10750-300-13150-350-14550.
