

Sub: Subordinate courts - Boycott /abstention of Courts - by the members of the Bar - Forwarding of reports to the High Court - Instructions issued - Compliance requested - reg.

The High Court, Madras considers that it becomes necessary to issue the following instructions for the effective administration of Subordinate Judiciary in the matter of boycotts of courts by members of the Bar.

All the Principal District Judges / District Judges / Principal Judge, City Civil Court, Chennai / Presiding Officers of other Courts / Tribunals under Special enactments, the Chief Judge, Puducherry and all other Judges holding independent charges shall report the instances of boycotts, immediately, then and there to the Registrar(Vigilance), High Court, Madras, over telephone.

The above said instructions shall be observed scrupulously, without any deviation. The deviation, if any, would be viewed seriously.
