AMENDMENT.

In the said Manual, in part-I, in paragraph 2 of Chapter II, the following sub-para shall be added at the end, namely:-

(P.T.O)

19/5/10

"The members of staff who are blind or physically handicapped shall be permitted to leave office early by fifteen minutes."
