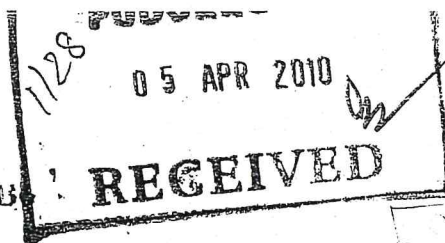

Sub: TNSJS - Instances of Judicial Officers availing leave in short spells frequently - noticed - instructions already issued to avoid such practice instructions issued for strict compliance - Reg.

- Read: 1. High Court's Circular in P. Dis. No. 70/68, (in Roc. No. 537A/68-B2 dated 15.2.1968)
2. High Court's Circular in Roc. No. 8852/90-B6, dated 17.12.1990.

In spite of specific instructions to avoid applying for leave in short spells frequently, of late, there have been instances of Judicial Officers availing such leave and thereby causing dislocation of court proceedings and consequential administrative problems.

The High Court views with great displeasure such availing of leave and extension of leave by the Judicial Officers.

As directed, all the Judicial Officers are directed to apply restraint and refrain from frequently applying for leave in short spells, keeping in mind their responsible position and also the ever increasing pendency of cases.

They are also directed that the earlier instructions issued in the matter of availing of leave/extension of leave, should be adhered strictly, without any deviation.

All the Judicial Officers are hereby informed that failure to comply with these instructions, may entail rejection of their leave application on administrative grounds.

The receipt of this Circular is required to be acknowledged at once.
