

Sub.: Email accounts for all the Judicial Officers and Hon'ble High Court Judges

Dear all the CPCs,

With reference to the subject noted above, the undersigned is directed to state that all the Judicial Officers of the country are supposed to be allotted email accounts under NIC mail domain indianjudiciary.gov.in. It has been observed that still many Judicial Officers in many parts of the country are not having indianjudiciary mail IDs. As official email ID is a must for all the Judicial Officers for attaining the objectives of the eCourts project, all the Judicial Officers have to be compulsorily provided with offical email ID under indianjudiciary mail domain, as early as possible.

For streamlining and expediting the process for creation and management of email accounts under the mail domain indianjudiciary.gov.in, the eCommittee, Supreme Court of India has been entrusted with the delegated administration of this mail domain. Therefore, it is hereby informed that, henceforth, all the email application forms for creating email accounts under the indianjudiciary mail domain and requests for password resetting etc., shall be directly sent to the office of the eCommittee through the Central Project Coordinators of all the High Courts. The email application form has been revised by the eCommittee and made available on the Supreme Court website at http://www.sci.nic.in/e-committee.htm. It is requested that only the forms available on the website of the Supreme Court of India must be used to apply for the email account. It is a two page form and has necessarily to be printed on both sides of a single paper. It is requested that all the Judicial Officers who do not have indianjudiciary mail account be informed to immediately apply on this form and send the same to the CPC at High Court for further transmission to the eCommittee after due endorsement by the CPC. Only the forms sent through and endorsed by the CPC shall be entertained.

The undersigned is directed to further state that the Judicial Officers who already have indianjudiciary email account are required to be impressed upon to use their email accounts regularly so as to get the optimum benefits of this modern mode of

paperless communication. It has been observed that a large number of email accounts are not being accessed for being disabled or passwords not working. In this regard, it is requested that a specific circular be sent for the notice of all the Judicial Officers to start using their email accounts regularly and if the accounts are not accessible, to immediately send the requests for enabling the email account and/or reset the password to the eCommittee through the CPC of the High Court. It is required that the Judicial Officer applying for enabling the email account or resetting the password of the email account should invariably send another alternate personal email ID with such request, to which his/her new password and/or account activation details shall be directly sent by the eCommittee. It is clarified that such requests shall be entertained only if they are forwarded through the designated email accounts of the CPC alongwith the information about the alternate personal email ID of the Judicial Officer. Once the account is enabled or password is reset, the intimation shall be sent to the CPC and the alternate personal email ID of the Judicial Officer. But the password shall be sent directly and only to the personal alternate email ID of the Judicial Officer by the eCommittee.

Furthermore, a separately devised form has also been uploaded on the above link for Hon'ble the Chief Justices and the Hon'ble Judges of the High Courts. All the email IDs being allotted to Hon'ble the Chief Justice and the Hon'ble Judges shall be prefixed with 'justice'. It is also requested that this information be brought to the kind notice of their Lordships, so that the email account facility may be extended, as desired.

It is further informed that all the Court establishments are also to be allotted email IDs under the mail domain indianjudiciary.gov.in. A different form shall have to be used to apply for the same. A separate communication about the policy and procedures for the email IDs for Court establishments shall be sent by the eCommittee soon.

It is also informed that the mail domain indianjudiciary.gov.in is accessible through all of these web addresses i.e http://webmail.nic.in

It is requested to make aware all the Judicial Officers about all the information contained in this letter.

Prompt action is highly expected.
