Sub: TNGSC Rules, 1973 – Instructions to the Judicial Officers to strictly adhere the Rule pertaining to movable properties and the submission of Return of Assets and Liabilities statement – Reg.
Ref: G. O. Ms. No.39, P & A.R. Dept., dated 09.03.2010.

The Principal District Judges / Head of city units concerned are hereby directed to instruct the Judicial Officers working in their District / Unit

(a) to submit their intimation with regard to the acquisition of movable properties out of their own savings; and/or disposal of the same, as required under Rule 7(2) of Tamil Nadu Government Servants' Conduct Rules, 1973, only if the value exceeds the said prescribed monetary ceiling as follows :-

| S.No. | Group to which Officers belong | Monetary ceiling |
|-------|--------------------------------|------------------|
| 1 | "A" | Rs.30,000/- |
| 2 | "B" | Rs.60,000/- |
| 3 | "C" | Rs.40,000/- |
| 4 | "D" | Rs.20,000/- |

and, if the value of the movable properties (acquired by utilising their own savings) is less than the prescribed monetary limits, they may be instructed not to give separate intimation regarding the same, but that they shall disclose them in their Return of Assets and Liabilities statement which is given every five years.

(b) to voluntarily submit their Return of Assets and liabilities as on 31st December, on or before 31st March of the succeeding year, quinquennially till their 53rd year and thereafter, annually till their superannuation.
