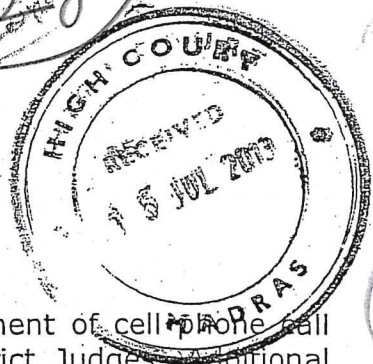

ABSTRACT

Cell Phones - High Court of Madras - Reimbursement of cell phone call charges to Judicial Officers in the cadre of District Judges, Additional District Judges and Civil Judges (Senior Division) in the State - Expenditure sanctioned - Orders - Issued.

ORDER:-

In G.O. first read above, the Government have issued orders that Secretaries and Special Secretaries be sanctioned reimbursement of an amount of Rs.1,200/- per month towards cell phones charges for using their private cell phones for official work.

2. The Registrar (Administration), High Court of Madras in his letter second read above has stated that now a days cell phones have become a necessity and so far as Judicial Officers are concerned, they can be contacted over phone at any time including holidays, even if the Officer concerned is not in headquarters. He has also stated that when Hon'ble Supreme Court Judges / High Court Judges are visiting a particular District / Town, it will be easy to contact the concerned District Judge as well as Judicial Officers for making necessary arrangements. He has further stated that at present 825 Judicial Officers are functioning in Tamil Nadu State Judicial Service, i.e., 112 Judicial Officers in the cadre of District Judge, 49 Judicial Officers in the cadre of Additional District Judge (Fast Tract Court), 206 Judicial Officers in the cadre of Civil Judge (Senior Division) and 458 Judicial Officers in the cadre of Civil Judge (Junior Division).

3. The Registrar (Admin), High Court of Madras has requested the Government to sanction a sum of Rs.1,18,80,000/- per annum towards the reimbursement of the call charges in respect of 825 Judicial Officers in the State at the rate of Rs.1200/- per month for using their cell phone for official purpose as per the orders issued in the G.O. first cited.

4. The Government after careful examination of the proposal of the Registrar (Administration), High Court of Madras have decided to sanction cell phone charges for the following 367 Judicial Officers who use their cell phones for official use on a sliding scale. Accordingly sanction is accorded for a sum of Rs.42,96,000/- per annum (Rupees forty two lakhs ninety six thousand only) (Rs.3,58,000/- per month x 12 months) towards the cell phone call charges for the 367 Judicial Officers who use their cell phones for official use at the rates as mentioned below:-

5. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account.

6. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" for which approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will initially be met by drawal of an advance from the contingency fund. The Finance (BG-I) Department will issue necessary orders separately. The Registrar General, High Court of Madras, Chennai is requested to apply for contingency fund advance in the prescribed format, for the required amount to Finance (BG-I) Department only with copies of this order. The Registrar General, High Court of Madras is also requested to send necessary explanatory notes to Government, in Finance Department to include the above expenditure in the Supplementary Estimates for the year 2013-14 at the appropriate time without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O. No.34647 (Home-II)/2013-1 Dated 08.07.2013 and with Additional Sanction Ledger No.592 (Five hundred and ninety two).

The President and General Secretary, Tamil Nadu Judicial Officers Association, Chennai, have requested in the letter first cited, to the High Court, that all Judicial Officers may be provided with free cellphone connections (instrument cost will be borne by the Officers themselves).

As on 01.02.2010, 825 Judicial Officers were functioning in Tamil Nadu State Judicial Service, (i.e., 112 Judicial Officers in the cadre of District Judge, 49 Judicial Officers in the cadre of Additional District Judge (Fast Track Court), 206 Judicial Officers in the cadre of Civil Judge (Senior Division) and 458 Judicial Officers in the cadre of Civil Judge (Junior Division)).

The Government in its G.O.(Ms) No.484, Home (Cts.VIA), Department, Secretariat, Chennai-9, dated 11.07.2013 have issued orders to sanction cell phone call charges for the following 367 Judicial Officers who use their cell phones for official use on a sliding scale. Accordingly sanctioned for a sum of Rs.42,96,000/- per annum (Rupees Forty-two lakhs and ninety six thousand only) (i.e., Rs.3,58,000/- per month x 12 months) towards the cell phone call charges for the 367 Judicial Officers who use their cell phones for official use at the rates as mentioned below:-

As on 23.07.2013 the sanctioned strength in the cadre of District Judges is 177 and working strength is 161 and sanctioned strength in the cadre of Senior Civil Judges is 228 and working strength is 206, the remaining Judicial Officers in the cadres of District Judges 16 ($177-161=16$) and Senior Civil Judges 22 ($228-206=22$) are to be provided with the cell phone call charges as the other Judicial Officers in that cadre.

The following 161 Nos. of District Judges may be provided with the cell phone call charges every month for a sum of Rs.1,200/-(Rupees one thousand and two hundred only) for their personal SIM card connections.
