Sub: Self Drawing Officers – difficulty in the claim of Pay and
Allowances for the intervening period on account of
transfer within the same audit control and
leave salary – reg. (())

Recently there have been many instances wherein the self drawing officers of Tamilnadu Government report their difficulty in claiming pay and allowances at the new treasury for the intervening period i.e., from the date of the last payment made at the old station till the date of relief when they are transferred from one place to another within the audit control of Principal A.G. and also difficulty in claiming the leave salary.

In this regard I am to state that various government rules viz instructions (e) under TN Treasury Rule 19, Note 3 under Instructions 7-8 TR 22 and Article 72 (d) of TN Financial Code Volume 1 regarding disbursal of pay and allowances at the time of transfer and instructions (c) under TN Treasury Rule 19, Proviso ii under instructions 7-8 TR 22 regarding leave salary clearly state that

- All the Government Servants transferred to new station shall be permitted to draw their pay and allowances for the period up to the date of relief at the old station itself.
- If any pay and allowances up to the date of relief is not paid to a Government servant at the old station owing to some reason or other, the LPC granted to him shall specify the last regular monthly payment and his entire pay for the month in which the transfer takes place shall be paid at the new station without insisting on this office authorisation for the intervening period.

: 2 :

- It is also insisted that the Treasury Officer issuing the LPC should clearly indicate there in, in column 6 of the LPC the complete information up to the date it is effective and also the details for payment of pay and allowances to be made from the date it is payable at the new station.
- Also self drawing officers who are appointed to the same post from which they proceeded on leave can draw pay and allowances at the same treasury on the basis of the pay slip issued for the duty pay before proceeding on leave.

The Treasury Officers at the new station shall commence making payment from the date following the date of last payment disbursed at the old treasury (in case of transfer) on the basis of LPC issued by the old treasury and this office authorisation for the transit pay and duty pay from the date of joining in the new station. Also leave salary can be paid based on the pay slip issued by this office for the duty pay, before proceeding on leave except in certain departments like ESI where ESI allowances are to be reduced during the leave period.

Hence suitable instructions may be issued to the Treasury Officers on the above lines to reduce time delay in claiming the pay and allowances during transfers and leave and reduce hardship to the Self Drawing Officers.
