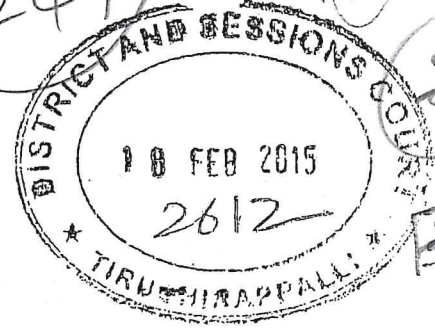


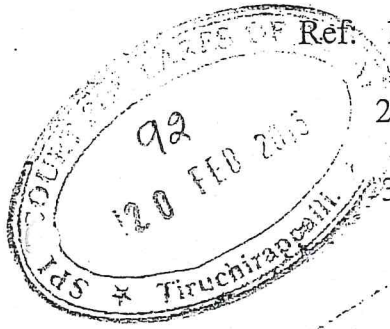

CIRCULAR

Sub: Courts and Judges – Transfer and Postings of Judicial Officers of all cadres in the Tamil Nadu State Judicial Service and Puducherry Judicial Service - Procedure to be followed - Informed.

The Judicial Officers of all cadres in the Tamil Nadu State Judicial Service and Puducherry Judicial Service are hereby informed that the procedure to be followed in the matter of transfer and postings of Judicial Officers of all cadres in the Tamil Nadu State Judicial Service and Puducherry Judicial Service has been deliberated in the Meeting of the Hon'ble Administrative Committee Meeting held on 28.01.2015 and as resolved, the following procedures are laid down:

1. The requests made by the Judicial Officers, who had completed three years of service in a station or within a District, would be considered on priority basis.
2. A Judicial Officer who had completed three years of service in a station or within a District, may be considered for a further extension of one year in the same station or in the same District, on his/her request, for special reasons. No further requests for retention in the same station or in the District would be entertained.

3. No requests would be entertained from a Judicial Officer, who had been transferred on promotion or for any other reason, within one year from the date of such transfer, except under extraordinary circumstances.
4. The requests for transfer by the Judicial Officer, who had not completed three years of service in a station or in a District, would not be considered, unless special or extraordinary reasons exist.

The receipt of this Circular is required to be acknowledged at once.
