CIRCULAR

Sub: Seeking Vigilance clearance for the staff of Subordinate Judiciary at the fag end of retirement- Avoiding of – Instructions issued.

Of late, it is noticed that Vigilance clearance is sought for, for the staff members of the Subordinate Judiciary at the fag end of their retirement on superannuation which causes difficulty in issuing clearance.

To avoid such situation, the Appointing Authorities are hereby directed to intimate the Vigilance Cell, High Court, Madras, the date of retirement of the staff members under their control well in advance, **at least 7 months prior to the date of their retirement** so that effective steps shall be taken by the Vigilance Cell by expediting the enquiries, if any, pending against them or by reminding the Appointing Authorities to submit the report on the complaints forwarded to them.

The Appointing Authorities are also directed to send the entire service particulars of the staff members for whom clearance is sought for and also inform the High Court as whether any enquiry is pending against them at their end.

This would facilitate the issuance of clearance by vigilance cell in time without delay thereby enabling the staff members to retire peacefully without mental agony.

The above instructions shall be followed scrupulously.
