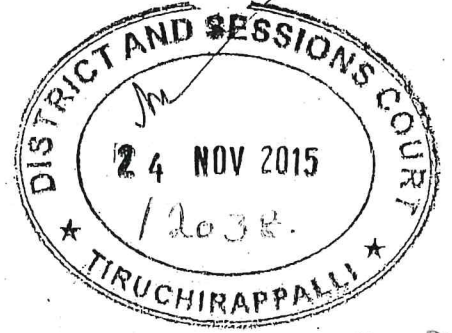

OFFICIAL MEMORANDUM

Sub:-Tamil Nadu Judicial Employees' Association, Chennai participated in All India Strike on 02.09.2015 -Intimated Certain Directions Issued.

Ref:- 1.Letter in Dis.No.1617, dated 31.08.2015 of the Chief Judge, Court of Small Causes, Chennai.

The High Court, while perusing the representation of the Tamil Nadu Judicial Employees' Association, Chennai and the report of the Principal District Judges/District Judges/Unit Heads with regard to the number of staff members participated in the strike on 02.09.2015, has issued the following directions,viz.,

(i) All the Principal District Judges/District Judges/Unit Heads, are hereby directed to issue a warning to the Staff members working under their control, not to take recourse to measures such as strike etc, making it clear that failure to adhere to the warning would be viewed seriously, resulting in appropriate disciplinary proceedings against the concerned".

and

(ii) All the Principal District Judges/District Judges/Unit Heads, are hereby further directed to recover one day salary of the staff members working under their control, who had participated in strike on 02.09.2015.
