ORDER:

In the Government Order first read above, the Government had enhanced the celling of House Building Advance to All India Service Officers from Rs.25,00,000/- to Rs.40,00,000/- and to State Government Employees from Rs.15,00,000/- to Rs.25,00,000/-.

2. The Chairman cum Managing Director, Tamil Nadu Generation and Distribution Corporation Limited (TANGEDCO) in his letter second read above has proposed to the Government to consider the novel idea of enabling the Government employees to install solar rooftops in their houses while availing the housing loans by permitting them to include the cost of the Rooftop Solar Photo Voltaic Power Plant in housing loan amount, within the existing ceiling limit. By including the cost of the Solar Rooftops in the existing House Building Advance amount without raising the ceiling limit, there will be no additional financial commitment to the Government as well as there would be huge reduction in demand of power supply in the domestic sector resulting in the mitigation of demand-supply mismatch.

3. The above proposal of the Chairman cum Managing Director, TANGEDCO Limited was examined by the Government and accordingly, it has been decided that the aspiring applicants who seek House Building Advance, may henceforth be permitted to include the cost of Rooftop Solar Photo Voltaic

4. Accordingly, the following amendment is issued to the State Rules to Regulate the Grant of Advances to Government Servants for Building, etc., of houses:-

In the said rules, in Form No.1 after Item No.XIV, the following shall be added:

"Item No.XV. Rooftop Solar Photo Voltaic Power Plant (Inclusive of Installation cost)".
