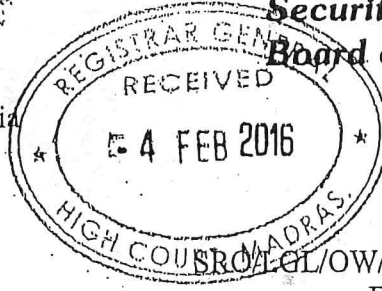

Sub: For issuance of necessary directions in terms of the Notification No. S.O. 1784(E) dated 01.07.2015 issued by the Central Government.

The Securities Laws (Amendment) Second Ordinance, 2013 (copy enclosed) promulgated by the President of India on September 16, 2013, *inter alia*, provides for establishment or designation of Special Courts by the Central Government for trial of offences under the Securities and Exchange Board of India Act, 1992, the Securities Contracts (Regulation) Act, 1956 and the Depositories Act, 1996. The said Ordinance have subsequently amended the Securities and Exchange Board of India Act w.e.f. 25.08.2014.

In this regard, vide letter no. SRO/LG/OW/33211/2013 dated December 20, 2013, SEBI had requested your kind office to take necessary steps for constitution of Special Court Chennai.

Subsequently, as you are aware, the Central Government, vide Notification No. S.O. 1784(E) dated 01.07.2015 (copy enclosed for ready reference), had designated Principal District and Sessions Court, Chennai as the Special Court under the SEBI Act. The gazette notification in this regard is attached herewith.

In view of the said Notification, you are requested to kindly issue suitable directions to the authorities concerned to operationalize the Special Court.
