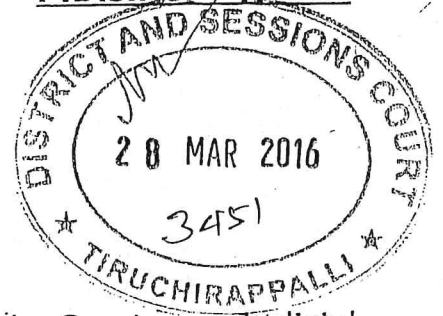

Sub: Subordinate Judiciary - Criminal Court - Judicial Magistrates - Receipt of FIR's - Certain instructions issued - Reg.

It is noticed by Hon'ble High Court that, the Judicial Magistrates while receiving the FIR's in many cases are not mentioning the time, place and date when it was received. This causes much hardship at the time of trial and at times, it paves way for the accused to escape from the clutches of law.

Therefore, all the Magistrates throughout the State shall strictly adhere the instructions mentioned hereunder without any deviation:-

"As and when a Magistrate receives a FIR with a complaint, he/she shall specifically mention the **TIME, DATE (alongwith year) and PLACE** at which the same is received by him/her and he/she shall also subscribe his/her full signature and write his/her name in capitals."
