rates of interest are general and will not anoth to takes at some rates of interest have been sanctioned specially by the Government or where to achieve have been sanctioned by the Government free of interest. The Government may also senction Ways and Means advances at special rates of interest taking into account the cost of borrowing of the Government.

- 4. The mobilization advances to Contractors for World Bank assisted Projects wherein the standard bidding documents provide for exemption from payment of interest.
- 5. The penal interest on all overdue instalments of principal and interest will be at 2.50 per cent in addition to the normal rates of interest per annum.
- 6. Except in the case of loans to Government Servants, interest in all cases unless specifically indicated otherwise should be paid every Calendar quarter on the outstanding balance.
- 7. Even at the stage of sanction of loan, in the sanction order, the period of repayment, rate of interest and schedule of repayment with dates shall be indicated. In case, it is a permanent loan, a specific mention of this fact should be made in the sanction order itself.
