ORDER:-

In the Government Order first read above, orders were issued constituting the Courts in the cadre of District Judge and Senior Civil Judge as Motor Accidents Claims Tribunal and appointing the Presiding Officers of the said courts as Members of the Motor Accidents Claims Tribunal and issued Notifications in supersession of Notification No.II(2)/HO/284/2001 dated the 21st February 2001 and issued Notifications No.II(2)/HO/884/2003 and Notification No.II(2)/HO/885/2003, dated 31st December, 2003.

2. The Registrar General, High Court of Madras has stated that after the publication of the said Notifications, so many new Courts in the cadre of District Judge and Senior Civil Judge have been constituted and consequent thereto, several amendments have been made to the said Notifications and hence, the Notifications have to be read alongwith and in consonance with the subsequent amendments made to them, which causes much difficulties.
