The attention of all the Judicial Officers in the cadre of Principal District Judge/District Judge/Chief Metropolitan Magistrate and Chief Judicial Magistrate, is drawn to the reference cited above and they are further directed to adhere to the following instructions scrupulously;

(a) Blue light with flasher as top light shall be strictly used without any deviation as per the G.O., issued by the Government of Tamil Nadu and in compliance with the order of the Supreme Court of India;

(b) Blue light with flasher on top and any emblem shall not be used in private cars;

(c) Emblem/name plates shall be used only in Official cars.

Any deviation of the above said directions will be viewed very seriously.
