Government Servants (Conditions of Service) Act, 2016 -

General Instructions - Reg.

Ref: Tamil Nadu Act, 14 of 2016.

I am directed to invite attention to the reference cited and to inform that Government have since enacted The Tamil Nadu Government Servants (Conditions of Service) Act, 2016 [Tamil Nadu Act No.14 of 2016] replacing the provisions of Part I and II of Tamil Nadu State and Subordinate Services Rules, published in Extraordinary issue of Tamil Nadu Government Gazette No. 207, dated 15.09.2016. This Act came into force on and from 15th September 2016 and is available in Government website www.tn.gov.in.

- 2. After the commencement of this Act, the general conditions of service of the Government Servants are, henceforth governed by the said Act. The provisions of Part I and II of Tamil Nadu State and Subordinate Services Rules became redundant and therefore no orders /proceedings be issued invoking the above rules. I am therefore to request you to invoke the respective sections of the Act in all orders wherever required in respect of all government servants (matters like appointment, probation, reservation, promotion panel, etc.,).
- 3. Further, I am to request you to take necessary immediate action to bring suitable amendments to the Special Rules for the respective services under your administrative control, for substituting the erstwhile provisions of Part I and II of [P.T.O.]
