## OFFICIAL MEMORANDUM

Sub: Courts and Judges – Judicial Officers applying leave frequently – directions issued to all the Judicial Officers of Tamil Nadu State Judicial Service and Puducherry Judicial Service – to avoid frequently applying for short spells of leave – Reg.

Ref: High Court's Circular in P.Dis.70/68, dated 15.2.1968.

The High Court, Madras, while sanctioning leave to the Judicial Officers, has noticed that, of late, the Judicial Officers of the Subordinate Judiciary apply for leave frequently, causing great inconvenience to the Court Proceedings.

As directed, all the Principal District Judges, District Judge, Chief Judicial Magistrates, Principal Judge, City Civil Court, Chennai, the Chief Judge, Court of Small Causes, Chennai, the Chief Metropolitan Magistrate, Egmore, Chennai and Others, are hereby informed to issue necessary instructions to all the Judicial Officers under their control to restrain and to refrain from frequently applying for short spells of leave, as far as possible, keeping in mind their responsible position and also the increasing pendency of cases. Frequent availing of leave would also enure to the negative side of such Officers and may even end up in rejection of their leave application.

All the Officers of Tamil Nadu State Judicial Service and Puducherry Judicial Service should also take notice of this Official Memorandum for strict adherence.

## P.Dis.70/68 CIRCULAR

Of late, there have been instances of Judicial Officers taking leave for short periods and extending leave piecemeal for short periods and thereby creating serious administrative problems in regard to postings, transfers etc. The High Court views with great displeasure such taking of leave and extensions of leave, by Judicial Officer. All the Judicial Officers are hereby informed that in future except for exceptional reasons, applications for leave should reach the High Court 15 days in advance of the date on which they intend to enter on leave, and they should also inform the High Court of their intention to rejoin duty or to apply for extension of leave at least 10 days before the expiry of the leave.

The officers are also further informed that failure to comply with these directions may entail rejection of their leave applications on administrative grounds.

They are also informed that they should not avail themselves of the leave in anticipation of sanction and that they should enter on leave only after receipt of orders of the High Court. The receipt of this circular is required to be acknowledged.
