Pursuant to the Government orders issued in seventh cited for certain allowances to the Judicial Officers/Retired Judicial Officers w.e.f. 01.01.2006, the High Court has issued a Proceedings vide reference eighth cited in this regard.

The Government have issued amendments in G.O. (Ms). No. 1077, Home (Cts.II) Department, dated 27.012.2010 to G.O. (Ms). No. 864, Home (Cts.I) Department, dated 05.10.2010, in respect of Housing and House Rent Allowances etc.,

In view of the amendment issued by the Government in the G.O., ninth cited, the Proceedings issued by the High Court's in-reference eighth cited under the Heading "16. Housing and House Rent Allowances", may be read as follows:

16(1) - shall be substituted as

"the Government quarters free of rent shall be provided to the Judicial Officers according to their entitlement and that no House Rent Allowance need be paid on such an allotment being made"

16(2) - shall be deleted

16(3) - shall be substituted as

"All Judicial Officers other than those who are provided rent free quarters are entitled to House Rent Allowances at the same rate as provided to the corresponding Government employees"

16(1-8) - shall be renumbered as 16(1-7)

Now, 16(8) shall be added as follows:

“The First National Judicial Pay Commission has recommended that a certain percentage of sites/houses, wherever they are available for allocation/allotment by the Housing Board/City improvement/Development Authorities etc., should be earmarked for allotment to Judicial Officers. Since, the Government have accepted the above recommendation, necessary orders will be issued separately as to the percentage of sites etc., in consultation with the Government in Housing and Urban Development Department and the Registrar General, High Court, Chennai.”
