ORDER:-

At present the following fixed rates are being
charged on the Officers for using the Staff Cars, namely:-

I. In the City of Madras:

- (i) Upto 8 K.Ms. .. Rs.75/- p.m.
- (ii) Over 8 K.Ms. upto 12 K.Ms. .. Rs.100/-p.m.
- (iii) Over 12 K.Ms. upto 16 K.Ms. .. Rs.125/-p.m.

II. In the Mofussil Station:

- (i) Upto 3 K.Ms. .. Rs. 30/-p.m.
- (ii) Over 3 K.Ms. upto 5 K.Ms. .. Rs. 50/-p.m.
- (iii) Over 5 K.Ms. upto 12 K.Ms. .. Rs.100/-p.m.

The charge of Rs.1.25 per K.M. is being collected from the Officers for using the Staff Car for private purposes but Rs.180/- (Rupees One hundred and eighty only) is charged for a maximum distance of 300 K.Ms. per month, and for distance travelled in excess of 300 K.Ms; the charge would be Rs.1.25 per K.M. Moreover, the consumption of fuel should not exceed the ceiling against which the monthly charges are collected for the following specified distances.

Sl. No.	Distance between the place of residence and Office.	Monthly charges	Monthly Ceiling upto which fuel can be allowed. (both for private and Official Purposes.
1.	Upto 8 K.Ms.	Rs. 75/-	100 litres
2.	Over 8 K.Ms. upto 12 K.Ms.	Rs.100/-	125 litres
3.	Over 12 K.Ms. upto 16 K.Ms.	Rs.125/-	150 litres

2. As the above charges were fixed as early as in 1975 the Government have examined the question of increasing the rates of fixed charges for the trips from the place of residence to Office and back and for private purposes for the use of staff cars by the Officers in consultation with the Director, Motor Vehicles Maintenance Department, Madras. The Government accordingly direct that the following rates of fixed charges be collected from the Officers for using the Government Vehicles who are entitled to avail such concession as ordered in G.Os. second to fourth read above.

I. In the City of Madras:

Sl. No.	Distance between the place of residence and Office.	Monthly charges	Monthly Fuel Ceiling for each vehicle allowed (both for Private and official purposes)
1.	Upto 8 K.Ms.	Rs.125/-	100 litres.
2.	Over 8 K.Ms. upto 12 K.Ms.	Rs.150/-	125 litres
3.	Over 12 K.Ms. upto 16 K.Ms.	Rs.175/-	150 litres

II. In the Mofussil Station:

(i)	Upto 4 K.Ms.	Rs. 60/-	50 litres
(ii)	Over 4 K.Ms. upto 8 K.Ms.	Rs. 125/-	100 litres
(iii)	Over 8 K.Ms. and upto 12 K.Ms.	Rs. 150/-	125 litres
(iv)	Above 12 K.Ms. and upto 16 K.Ms.	Rs. 175/-	150 litres

The Government also direct that the revised rate of Rs. 3/- per K.M. be collected over and above the normal quota. Alternatively the Official can go in for a flat rate of Rs. 400/- for extra 200 K.Ms. and in excess of 200 K.Ms. a rate of Rs. 3/- per K.M. may be collected for using the vehicle for private purposes. This facility will be available only to Officers entitled to the use of the vehicle from home to Office and back.

3. The Government also direct that the rate of Rs. 3/- per K.M. shall be collected from the Government Servant who uses the Government vehicle for private purposes. *Silva*

4. Other orders already in force for the use of Government vehicle and rule 4 of the Tamil Nadu Departmental Vehicles Control Rules, 1976 shall be followed.

5. The Director, Motor Vehicles Maintenance Department, Madras is requested to send necessary draft amendment to rule 4 of the Tamil Nadu Departmental Vehicles Control Rules, 1976 with reference to orders in paras 2 and 3 above.

6. This order issues with the concurrence of Finance Department vide its H.O.No. 62055/H1/93, dt. 7.7.93.
