**ORDER:**

In the Government Order first read above, orders were issued fixing the rate of interest for the accumulation at the credit of the subscribers to the Contributory Pension Scheme at **7.8%** (Seven point eight per cent) for the period from 1<sup>st</sup> October, 2017 to 31<sup>st</sup> December, 2017.

2. In the Government Order second read above, the rate of interest for accumulation at the credit of subscribers to the General Provident Fund [Tamil Nadu] were fixed at the rate of **7.6%** (Seven point six per cent) with effect from 1<sup>st</sup> January, 2018 to 31<sup>st</sup> March, 2018.

3. The Government now direct that the rate of interest on the accumulation at the credit of the subscribers to the Contributory Pension Scheme shall carry interest at the rate of **7.6%** (Seven point six per cent) with effect from 1<sup>st</sup> January, 2018 to 31<sup>st</sup> March, 2018.
