

## ORDER:-

In the Order first read above, the Government have sanctioned two advance increments to the Judicial Officers who possess M.L.Degree.

- 2. The Registrar General, High Court of Madras in his letter second read above, has requested the Government to sanction one more increment, in addition to 2 increments already sanctioned in the G.O. first read above, i.e. 3<sup>rd</sup> increment to the Judicial Officers, who are having higher qualification (i.e. M.L/L.L.M Degree) as recommended by the Shetty Commission.
- 3. The Government, after careful examination, have decided to accept the request of the Registrar General, High Court of Madras and accordingly direct that the Judicial Officers who possess M.L./L.L.M. Degree, be granted one more increment in addition to the 2 increments already sanctioned in the G.O. first read above, with effect from the date of issue of this order, as recommended by the Shetty Commission.
- 4. The advance increments can be sanctioned only once and are not admissible after a stage of promotion from the post, pay in respect of which has already been fixed, taking into account the advance increments also.



That is, the advance increments are not admissible for each stage of promotion without restriction.

5. This order issues with the concurrence of the Finance Department vide its U.O.No.22777/Fin(Home-II)/2018, dated 08.05.2018.
