



ABSTRACT

Directorate of Vigilance and Anti-Corruption – Formation of new detachments at Thiruvallur, Thiruvarur and Perambalur Districts – Declared as Police Stations under section 2(s) of Code of Criminal Procedure, 1973 – Assigning specific jurisdiction to all Directorate of Vigilance and Anti-Corruption detachments – Amendment to Notification issued.

ORDER :

In the Government Order first read above, the detachment offices (20 districts) of the Directorate of Vigilance and Anti-Corruption were notified as Police Stations specifying their jurisdiction, under clause (s) of section 2 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974).

2. In the Government Order second read above, the detachments at Cuddalore and Madurai were bifurcated as Cuddalore, Villupuram and Madurai, Theni, respectively and notified as Police Stations and entered in the Table as Sl.No. 2.Cuddalore, 7.Madurai, 21.Villupuram and 22.Theni with respective Jurisdiction.

3. In the Government Order third read above, the Dharmapuri detachment has been bifurcated into Dharmapuri and Krishnagiri and the Krishnagiri detachment has been notified as Police Station as "23.Krishnagiri Detachment" with the jurisdiction of Krishnagiri.

4. In the Government Order fourth read above, the Salem detachment has been bifurcated into Salem and Namakkal and the Namakkal detachment has been notified as Police Station and added to the Table as "24.Namakkal Detachment" with the Jurisdiction of Namakkal.

5. In the Government Order fifth read above, on bifurcation from Coimbatore and Vellore detachments; Tiruppur Detachment and Thiruvannamalai detachment were created and notified as Police Stations and entered in the Table as "24.Tiruppur Detachment" with Tiruppur Jurisdiction and "25.Thiruvannamalai Detachment" with Thiruvannamalai Jurisdiction, respectively.

6. In the Government Order sixth read above, on creation of Ariyalur District, Ariyalur detachment has been created and notified as Police Station and entered in the Table as "26.Ariyalur Detachment" with the jurisdiction of Ariyalur.

7. In the Government Order seventh read above, based on the Court direction, detachment at Karur district has been created and notified as Police Station and entered in the Table as "27.Karur Detachment" with the Jurisdiction of Karur.

8. In the Government Order eighth read above, orders were issued by creating separate Directorate of Vigilance and Anti-Corruption detachments at Thiruvallur, Thiruvarur and Perambalur Districts. Consequent to the creation of above Detachments, the Director, Vigilance and Anti-Corruption has requested to issue notification declaring the said three Detachments as Police Stations, under clause (s) of section 2 of the Code of Criminal Procedure, 1973.

9. The Director of Vigilance and Anti-Corruption has further stated that, under clause (s) of section 2 of the Code of Criminal Procedure, 1973, all the Detachments of that Directorate have to be formally declared as Police Stations, specifying the jurisdiction to be covered under the respective detachments, so that criminal cases could be registered and investigated by the Officers of the Detachment of and above the rank of Inspector of Police who have been notified to have the powers of an Officer in charge of a Police Station.

10. Meanwhile, it is noticed that the "Sl.No.24 has occurred twice in the Table inadvertently while notifying the Namakkal Detachment and consequent to the above, further entries have also been entered wrongly. Further, it is noticed that while creating separate detachments to Directorate of Vigilance and Anti-Corruption at each districts, the specific jurisdiction has not been mentioned in the notifications.

11. Considering the above and also considering the fact that almost all the districts are having separate Directorate of Vigilance and Anti-Corruption detachments, the Government after careful examination, have decided to amend the notification issued with Government Order (Ms.) No.88, Personnel and Administrative Reforms (N) Department, dated 15.05.2001 as subsequently amended with specific jurisdiction with effect from the date of its original notifications by substituting the Table.

12. Accordingly, the following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

Under clause (s) of section 2 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu hereby makes the following amendment to the Personnel and Administrative Reforms Department Notification No.II(2)/PLAR/523/2001, dated the 15th May 2001, published at page 249 in Part II – Section 2 of the Tamil Nadu Government Gazette, dated the 13th June 2001, as subsequently amended:-
