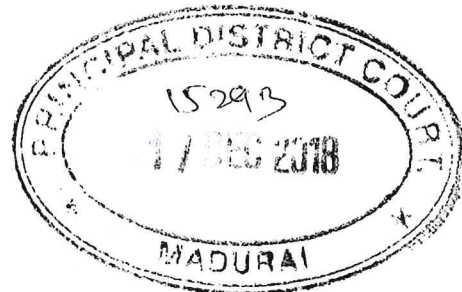

With reference to the Government letters 8th and 9th cited, I am directed to inform that the Court of Principal Judge, City Civil Court, Chennai and the Principal District Courts / District Courts of the Districts in the State of Tamil Nadu may be constituted as Tribunal for the purpose of Section 38 of the Tamil Nadu Private Colleges (Regulation) Act, 1976.

In view of the above, I am further directed to forward herewith the draft notification for constituting the Court of Principal Judge, City Civil Court, Chennai and the Principal District Courts / District Courts of the Districts in the State of Tamil Nadu as the Tribunal for the purpose of Section 38 of the Tamil Nadu Private Colleges (Regulation) Act, 1976, in supersession of the earlier notification issued in G.O.(Ms). No.672, Education Department, dated 25.04.1979, which is enclosed in the Annexure to this letter and to request that the same may be published in the Tamil Nadu Government Gazette.

ANNEXURE

Constitution of Principal District Courts of the Districts as the Tribunal for the purpose of Section 38 of the Tamil Nadu Private Colleges (Regulation) Act, 1976

Draft Notification

WHEREAS the appropriate Government as per Sub-Section (1) of Section 38 of the Tamil Nadu Private Colleges (Regulation) Act, 1976, shall for the purpose of hearing and adjudicating the disputes relating to appeals preferred by teachers and other persons employed in Private Colleges, by notification, constitute as many Tribunals as may be necessary for the purpose of this Act, and as per sub-section (2) of Section 38 of the aforesaid Act, each Tribunal shall consist of one person only who shall be a Judicial Officer not below the rank of a District Judge and as per sub-Section (3) of Section 38 of the aforesaid Act, each Tribunal shall have such jurisdiction and over such area or in relation, to such class of private colleges, as the Government may, by notification, from time to time, determine, and as per Sub-Section (4) of Section 38 of the aforesaid Act, every Tribunal shall have the same powers as are vested in a Civil Court under the Code of Civil Procedure, 1908 (V of 1908), while hearing an appeal.

In exercise of powers conferred by Sub-Sections (1), (2),(3) and (4) of Section 38 of the Tamil Nadu Private Colleges (Regulation) Act, 1976, the Governor of Tamil Nadu, in supersession of the earlier Notification issued in G.O.(Ms) No.672, Education Department, dated 25.04.1979, hereby declares the Courts specified in column (3) of the Table below as " Tribunal " for the District specified against the corresponding entries in column (2) thereof, and hereby appoints the Principal Judge / Principal District Judge / District Judge specified in column (4) as Presiding Officer of the respective Tribunal specified in column (3) thereof, **to entertain, hear and adjudicate the disputes** relating to appeals
