ORDER:-

In the Government order first read above, the Government have authorized the Inspector General of Registration, Chennai to enter into an agreement with M/s. Stock Holding Corporation of India Limited, so as to implement the Levy of fee by e-Stamp system for Judicial Stamps in all the courts in the State of Tamil Nadu. Orders were also issued therein by directing the Inspector General of Registration to proceed forthwith for Levy of fee by e-Stamp for Judicial stamps in all the courts in the State of Tamil Nadu in consultation with M/s.Stock Holding Corporation of India Limited and the Registrar (IT-cum-Statistics), High Court of Madras and other stake holders. Accordingly, levy of fee by e-Stamping for judicial stamp has been in vogue in the High Court of Madras and its Madurai Bench.

2. In his letter second read above, the Registrar General, High Court of Madras has forwarded the letter of M/s.Stock Holding Corporation of India Limited, wherein the Regional Manager of the said Agency has stated that M/s.Stock Holding Corporation of India Limited is the sole Central Record keeping agency for e-Stamping with respect to Non-Judicial stamps. She has further stated that Advocates comprise the major section of public who use Non-Judicial stamps and they have been requesting e-Stamping (Non-Judicial) also to be issued from the e-Court fee counters at the premises of the High Court in Chennai and Madurai. She has, therefore, sought for permission for sale of Non-Judicial e-Stamps also from the counters at the premises of the High Court of Madras and its Bench at Madurai.

- 3. The Registrar General, High Court of Madras has stated that he has no objection for extending the facility for sale of Non-Judicial e-Stamps in the same counters at Principal Seat and Madurai Bench of Madras High Court, without detriment to the services rendered by M/s. Stock Holding Corporation of India Limited to the Advocates with regard to the sale of Judicial e-Stamps.
- 4. In his letter third read above, the Inspector General of Registration, Chennai has stated that the Government may permit M/s. Stock Holding Corporation of India Limited to sell Non-Judicical e-Stamps from the present e-Court fee selling counters at the premises of the High Court of Madras and its Bench at Madurai.
- 5. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the Government accord permission to M/s.Stock Holding Corporation of India Limited, Chennai to sell Non-Judicial e-Stamps from the counters at the premises of the High Court of Madras and its Bench at Madurai
