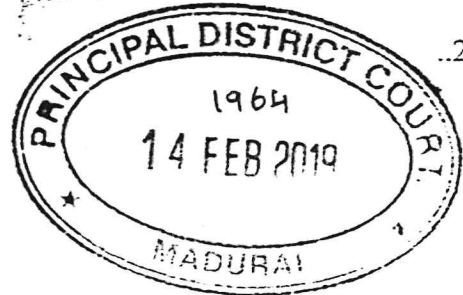

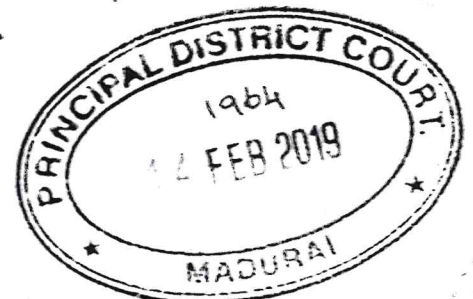
Sub: Designating Special Court for the purposes of Prohibition of Benami Property Transactions Act, 1988 - reg.
