The Hon'ble First Division Bench of the Madras High Court in the Suo Motu W.P.No.15640/2018, dated 16.07.2018, has directed the Government to ensure that all Officers and Employees of the Government of Tamil Nadu, particularly, those dealing with the public are provided with Photo Identity Cards, within sixty (60) days from date, if the same has not already been done. The Government was further directed to ensure that the Rule regarding wearing of Identity Cards is strictly enforced and action be taken against those flouting the Rule.

In obedience to the above direction, the Registry of Madras High Court has issued Circular in the reference 2<sup>nd</sup> cited, directing all the Staff Members and Officers upto the cadre of Joint Registrars of the Madras High Court to visibly wear the Identity Cards issued to them while on duty/till they leave the Office.

Pursuant to the directions of the First Division Bench cited, the Secretary to Government, Personnel and Administrative Reforms (A) Department, Secretariat, Chennai, in the letter 3<sup>rd</sup> cited, has requested all the Head of the Departments/District Collectors to give suitable instructions to the subordinate officers and Employees under their control to wear photo identity cards without fail



as per the norms and instructions specified in the Government Orders/Instructions issued in the Government Orders/Letters mentioned in the reference, therein.

Therefore, the Additional Registrar General, Madurai Bench of the Madras High Court, Madurai, all the Principal District Judges in the State of Tamil Nadu including the Chief Judge, Puducherry, are required to give suitable instructions to the employees working under their control to wear Photo Identity Cards without fail, as per the norms and instructions specified in the Government Orders /Letters, mentioned therein in the Government Letter 3<sup>rd</sup> cited.
