Abstract

Tamil Nadu Revised Scales of pay, 2009 – Revision of Grade pay to the Junior Bailiff in District Courts—Orders—Issued.

ORDER:

Based on the recommendations of the Official Committee, the Senior Bailiffs in the District Courts were granted the revised pay scale of Rs. 5200 - 20,200 + Grade pay Rs. 2000 as against the pre-revised pay scale of Rs. 3200 - 4900 equal to the post of Junior Assistant, notionally with effect from 01.01.2006 with monetary benefit from 01.01.2007. Subsequently, in G.O.Ms.No.45, Finance (PC) Department, dated 10.2.2011, among others, orders have been issued revising the pay scale of Junior Assistant from Rs.5200 - 20,200 + Grade pay Rs.2000 to Rs.5200 - 20,200 + Grade pay Rs.2400 notionally with effect from 01.01.2006 with monetary benefit from 01.02.2011.

2. Consequent on the revision of pay scale granted to the Junior Assistants, the Tamil Nadu Bailiff Association, State Center, Madurai District Court, represented by its President Thiru.T.Thambithurai, filed W.P.(MD).No.11390 of 2011 with a prayer to revise the scale of pay of Senior Bailiffs as Rs.5200-20,200 + Grade pay Rs.2400 on par with Junior Assistants / Typists The Honble High Court of Madras, Madurai Bench in its order dated. 07.03.13 in W.P.(MD)No.11390 of 2011 passed orders for granting the higher Grade Pay sought for in the representation dated

05.03.2013. The above matter was referred to the Pay Grievance Redressal Cell. Based on the recommendations of the Pay Grievance Redressal Cell, among others, orders were issued in the Government Order third read above, revising the pay scale pay Rs.2000 to Rs.5200-20,200 + Grade pay Rs.2400 notionally with effect from 01.01.2006 with monetary benefit from 01.04.2013 and the above Grade Pay enhancement was also made applicable to the Senior Bailiff in the District Courts.

- 3. Subsequently, the Civil Court Process Server Association, Thanjavur in their representation dated. 09.07.2012 has requested to extend the benefit of enhancement in Grade Pay to the similar post in District Courts.
- 4. Accordingly, in the Government letter fourth read above, it was clarified that the enhancement of Grade Pay to the Junior Bailiff in High Court as ordered in the Government Order third read above is also applicable to the Junior Bailiff in District Courts.
- 5. The Accountant General has now brought to notice that the pre-revised pay scale of Junior Bailiff in District Courts is Rs.3050-4590 is one level lower than the Junior Bailiff in High Court (Rs.3200 4900) and therefore sought clarification as to whether the enhanced Grade Pay is applicable to the Junior Bailiff in the District Courts who were drawing the revised pay scale of Rs.5200-20,200 + Grade pay Rs.1900 corresponding to the pre-revised pay scale of Rs.3050-4590.
- 6. In the meantime, the Tamil Nadu Bailiff Association has again filed W.P.(MD).No.3448 of 2015 to consider their earlier representations and also to increase the Grade Pay of Senior Bailiff in the District Courts from Rs.2400 to Rs.2800 and pass appropriate orders within the time limit fixed by the Court.
- 7. The above issue has been re-examined in detail and it is observed that the enhanced Grade Pay of Junior Bailiff in High Court was inadvertently extended to the Junior Bailiff in District Courts, who were placed one level below the Senior Bailiffs in the District Courts both in the pre-revised and revised pay scales as pay Rs.2000 (Rs.3200-4900), respectively. As such it would be appropriate to place the Junior Bailiff in District Courts at a level below the Senior Bailiff in the District Courts.
- 8. The Government after careful consideration, direct that the clarification issued in the Government letter fourth read above, be cancelled with immediate effect and the Junior Bailiff in District Courts be appropriately placed at Rs.5200-20,200 + Grade pay Rs.2200 one level below the Senior Bailiffs in District Court (Rs.5200-20,200 + Grade pay Rs.2400) with notional effect from 1-1-2006 and monetary effect from the date of issue of this Order.
- 9. The Government also direct that the excess payment made, based on the Clarification issued in the Government letter fourth read above, if any be waived as a special case.

10. Consequent on the revision of Ordinary Grade scale of pay of Junior Bailiff as Rs.5200-20,200 + Grade pay Rs.2200, the Selection Grade and Special Grade scales of pay shall be Rs.5200-20,200 + Grade pay Rs.2400 and Rs.5200-20,200 + Grade pay Rs.2800 respectively as per Government letter No.63305 / Pay Cell / 2010-1, Finance, dated. 08.11.2010.

11. The Registrar General, High Court shall issue necessary instructions to all the Principal District Judges to re-fix the pay of Junior Bailiffs in the District Courts in the appropriate pay scales as ordered above.





Your kind Attention is drawn to Letter No.76751/Cts.V/2011-4 dated 31/12/2012 wherein it is stated that those holding the post of Junior Bailiff (Process Server) does not have any promotional avenue and hence Selection Grade/Special Grade shall not be restricted. Originally this office had been admitting the cases for the post of Selection Grade Junior Bailiff in the pay scale of 3200-4900 and Special Grade Junior Bailiff in the pay scale of 4000 - 6000 restricting to 1st level/2nd level of promotional posts. But after the issue of above referred Government Letter cases were finalised in 4000-6000 scale of pay for the post of selection Grade Junior Bailiff 4300 -6000 scale of pay for the Special Grade Junior Bailiff without restricting to 1st level/2nd level of promotional posts.

Further as per G.O.193 dated 6/7/2015 pay scale of Junior Bailiff has been revised to 5200-20200 + 2200 (Grade Pay), that of Selection Grade and special Grade to 5200-20200 + 2400 (Grade Pay) and 5200-20200 + 2800 (Grade Pay) respectively.

Now In Government Letter No.74128/Cts.V/2016-3 dated 27/3/2017, it has been clarified that pay scale of Junior Bailiff in the Selection Grade/Special Grade has to be restricted to 1st level/2nd level of promotional posts. As this office had already admitted Pensionery benefits in pay scale of Selection



I request to arrange to send an early reply on Priority basis as this office has been receiving many writ petitions and representations under R.T.I in this matter.



Accordingly, in the Government order $1^{\rm st}$ cited the Junior Bailiff in the District Courts were appropriately placed at Rs.5200-20200 + GP 2200 one level below the Senior Bailiffs in District Courts Rs.5200-20200 + GP 2400.
- 3. Consequent on the revision of Ordinary Grade Scale of pay of Junior Bailiff as Rs.5200-20200 + GP 2200, the Selection Grade and Special Grade Scales of pay shall be fixed at Rs.5200-20200 + GP 2400 and Rs.5200respectively, GP 2800 Government as per No.63305/PC/2010-1 Finance Department dated:08.11.2010. Further in Letter No.11718/PC/ Finance Department, Government : 2014-1 dated:13.03.2014, it has also been ordered that the excess payment made may be waived as a special case.

4. I am therefore to request you to waive the excess payments made to the Junior Bailiffs as a special case. However, refixation of pay and pension should be appropriately fixed as per the existing orders after giving due notice to the individual concerned.
