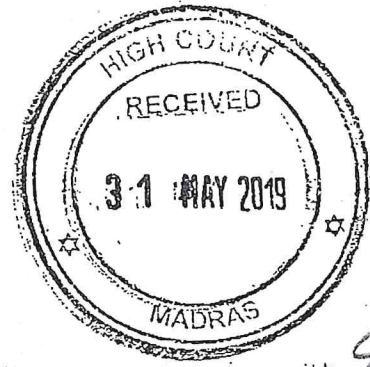

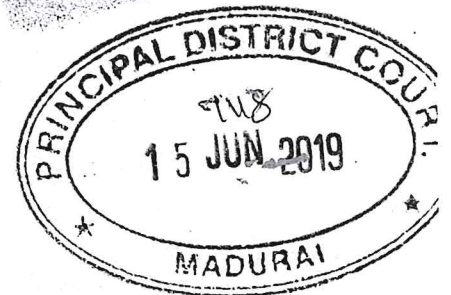
NOTIFICATION.

In exercise of the powers conferred by section 84 of the Right of Persons with Disabilities Act, 2016, (Central Act 49 of 2016) the Governor of Tamil Nadu, with the concurrence of the Chief Justice of the High Court, Madras, hereby designate the Court of the Principal Judge, City Civil Court, Chennai and the Principal District Court / District Court in each Judicial District in the State of Tamil Nadu as the Special Courts, specifying the entire territorial limits of the Judicial District concerned as the local limits of the area to which the jurisdiction of the respective Court shall extend and also appoints the Principal Judge, City Civil Court, Chennai and the Principal District Judge/District Judge of the respective Judicial District as the Judge of the respective Special Court to try the offences under the said Act.
