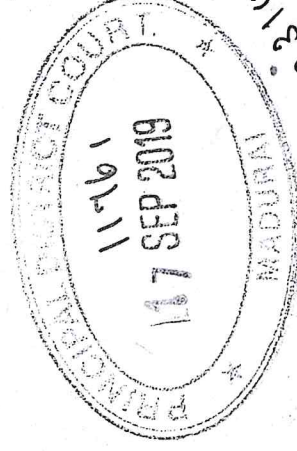

ORDER:-

Hon'ble Minister (Fisheries & Personnel and Administrative Reforms Department) on 05.07.2019, in the floor of Tamil Nadu Legislative Assembly, has made the following announcement:-

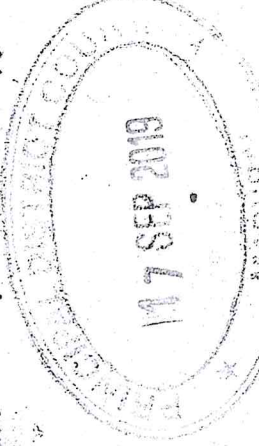

புற்று நோயினால் பாதிக்கப்பட்ட அரசுப் பணியாளர்களின் நலனை கருத்தில் கொண்டு, தற்போது அனுமதிக்கப்பட்ட விடுப்புகளுடன், கீமோ தெரபி (Chemo-therapy) மற்றும் ரேடியோ தெரபி (Radio-therapy) சிகிச்சை பெறும் ஒவ்வொரு முறையும், அவர்களுக்கு முழு ஊதியத்துடன் 10 நாட்கள் சிறப்பு விடுப்பு வழங்கப்படும்."

2. In the letter first read above, the Director of Public Health and Preventive Medicine, Chennai has sent the following suggestion to the Government:-

"A Leave period of 10 days, starting from the day before the first day of Chemotherapy can be granted as Special Leave for the benefit of the Government Servants undergoing Chemotherapy for Cancer, as the patients undergoing chemotherapy will have to visit the hospital one day before the scheduled date for chemotherapy for undergoing pre-chemo investigations and require another 8 days for recovery. (1 day prior to the date of chemotherapy + 1 day for chemotherapy + 8 days for recovery Total = 10 days)"

3. In the letter second read above, the Health and Family Welfare Department has forwarded the above suggestion for examining the feasibility of granting short term special leave (Spl. C.L.) on medical certificate other than eligible leave for undergoing Chemotherapy / Radiotherapy treatment for Cancer as and when required.

4. The Government after careful consideration accept the above suggestion of Director of Public Health and Preventive Medicine and directs that Special Casual Leave be granted to a Government Servant who is undergoing Chemotherapy / Radiotherapy treatment for Cancer, every time, for a period of 10 days starting from the day prior to the date of Chemotherapy / Radiotherapy, over and above, the other eligible leave to him, subject to the production of the Medical Certificate from the Medical Officer in-charge of a medical institution of her / his having undergone the said treatment.

5. Necessary amendments to Fundamental Rules will be issued, separately.
