



I am to invite a reference to the letters 2nd and 3rd cited, wherein you have requested the High Court to issue suitable instructions to the Execution Courts and other Civil Courts, which deal with the Execution of the decrees of already existed Waqf Tribunals, not to transfer the Execution Petitions pending before them to the Tamil Nadu Waqf Tribunal, Chennai and also to receive the Execution Petitions transmitted by the Waqf Tribunal, Chennai in the future
