### ORDER :

Orders were issued in the Government order read above that the nomenclature of the certain posts such as, Cleaners, Sanitary Workers, Sweepers, Watchmen-cum-Sweepers, Assistant Sweepers, Waterman-cum-Sweeper, classified under Tamil Nadu Basic Service shall be changed into 'Cleanliness Workers'. It was also ordered that the Special Rules for Tamil Nadu Basic Service shall be amended suitably.

2. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Basic Service (Section 19 in Volume III of the Tamil Nadu Services Manual, 2016).

2. The amendments hereby made shall be deemed to have come into force on the 18<sup>th</sup> December 2020.

### AMENDMENTS

In the said Special Rules,-

(1) in Rule 1, under Class IV,-

(a) against Category 7, for the expression “Cleaners”, the expression “Cleanliness Workers” shall be substituted;

(b) against Category 8, Category 12 and Category 34, the expressions “Sanitary Workers”, “Sweepers” and “Assistant Sweepers” shall, respectively, be omitted;

- (c) against Category 32, for the expression "Watchmen-cum-Sweepers", the expression "Watchmen-cum-Cleanliness Workers" shall be substituted;
- (d) against Category 79, for the expression "Waterman-cum-Sweeper", the expression "Waterman-cum-Cleanliness Worker" shall be substituted;
- (2) in rule 3, in the second proviso, for the expression "Sanitary Workers", the expression "Cleanliness Workers" shall be substituted;
- (3) in rule 5, in sub-rule(1), in the sixth proviso, for the expression "Sweepers, Sanitary Workers", the expression "Cleanliness Workers" shall be substituted.
