SUB:- Preparing the Preamble Portion of the cases before pronouncement of Judgment by Stenographers of Subordinate Judiciary -Instructions Issued -Reg.

It is learnt that Stenographers of the Subordinate Judiciary are allowed to prepare the Preamble of the Judgment, even before pronouncement of Judgment. While doing so, they are in the habit/practice of copying the contents of the similar case and change the contents accordingly.

It is further learnt that they are also entrusted with the work of uploading the Judgments pronounced in the E-Courts Portal through the server.

A specific instance has been brought to the notice of the High Court where a Judgment only with its Preamble portion and result portion without discussion portion, which has been prepared well in advance before the pronouncement of Judgment by cut and paste from a similar case had been inadvertently uploaded in the E-Courts Portal thereby creating unnecessary confusion to the Litigants and also giving room to complaints.

Hence, in order to avoid such unpleasant events, all the Presiding Officers are hereby instructed to desist from the practice of allowing the stenographers to prepare preamble portion of the Judgment, so that such mistakes could be prevented/avoided.

The above instructions shall be strictly adhered to. Any deviation in following the above instructions shall be viewed seriously.
