OFFICIAL MEMORANDUM

Sub: Buildings - Permission to the Officers for the cadre of District Munsif/Judicial Magistrate, Sub Judge, Chief Judicial Magistrate/Chief Metropolitan Magistrate (1) to stay away from the Head Quarters (2) to stay in the private rented house building and to claim reimbursement of excess rent (3) to stay in the post attached quarters after the Judicial Officers retirement/transfer/promotion - Delegation of Powers to the Principal District Judges/District Judges, in the State - Orders issued.

As directed, it is hereby informed that the Hon'ble High Court, Madras, has considered and decided to delegate certain powers to Principal Judge, City Civil Court, Chennai-104, all the Principal District Judges/District Judges, in the State, with regard to the requests received from the Judicial Officers in the cadre of District Munsif/Judicial Magistrate, Sub Judge and Chief Judicial Magistrate/Chief Metropolitan Magistrate, for the following subjects for granting permission;

1. Requests seeking permission to stay away from the headquarters, by considering the genuinity of the grounds by following the rules/procedures/G.Os./Orders of the Hon'ble Supreme Court of India and Hon'ble High Court, Madras, if any, from time to time;
2. Requests seeking permission to stay in the private rented house buildings and to claim the reimbursement of excess rent in cases of non availability of post attached quarters/conditions of said buildings/safety and security/ and any other personal reasons, by considering the genuinity of the grounds by following the rules/procedures/G.Os./orders of the Hon'ble Supreme Court of India and Hon'ble High Court, Madras, if any from time to time;

Requests seeking permission to stay in the post attached quarters after the Judicial Officers retirement / transfer/promotion, by considering the genuinity of the grounds by following the rules/procedures/G.Os./orders of the Hon'ble Supreme Court of India and Hon'ble High Court, Madras, if any, from time to time;
4. The Principal Judge, City Civil Court, Chennai, and all the Principal District Judges/District Judges are hereby informed that, if they consider that the orders of the Hon'ble High Court, Madras, are necessary, for any of the above subject, may be addressed to High Court, Madras, and;
5. The powers above delegated are subject to any further directions/modifications of the Hon'ble High Court, Madras.
