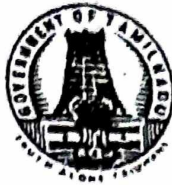

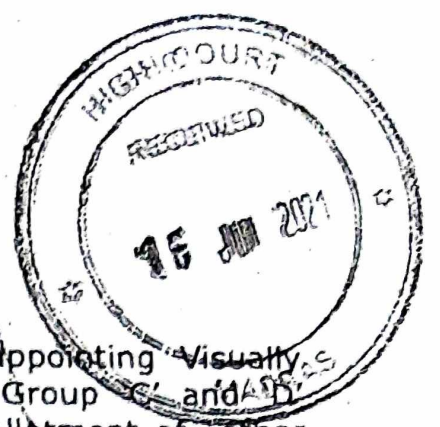

ORDER :

In the letter first read above, the Registrar General, High Court of Madras has stated that in the light of nature of duties and responsibilities being performed in the Courts at District levels, it is not possible to accommodate the Visually Impaired differently abled candidates. Hence he has requested the Government to exempt the Judicial Department in allotting visually impaired differently abled candidates to Subordinate Courts in the State of Tamil Nadu which fall under Group 'C' and 'D'. He has further requested that the other differently abled persons in the same percentage (i.e., 4%) except the visually impaired differently abled candidates may be allotted, to the Subordinate Courts in the State of Tamil Nadu.

2. In G.O.(Ms).No.51, Welfare of Differently abled persons (DAP-3.2) Department, dated 26.12.2017, among other things, orders were issued as follows;

"if any department / establishment is of the view that any particular post in 'C' and 'D' category is not suitable for differently abled persons, in such case, it may specifically request the Government for exemption. The administrative department in consultation with the State Commissioner for

the Differently Abled and the Government shall issue appropriate orders".

3. In the letter second read above, the Commissioner for Welfare of the Differently Abled has stated that in the light of the provisions contained in section 34 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016) and considering the nature of work in respect of posts included in Groups "C" and "D", in Judicial department, the Judicial department may be exempted from implementing 4% reservation to the visually impaired differently abled persons for the posts included in Groups "C" and "D". The Commissioner for Welfare of Differently Abled has also informed that they have no objection in issuing exemption to the above group of posts for the visually impaired differently abled candidates.

4. The Government, after careful examination, have decided to accept the proposal of the Registrar General, High Court of Madras, Chennai, after considering the remarks of the Commissioner for Welfare of the Differently Abled. Accordingly, the following Notification shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the second proviso to sub-section (1) of section 34 of the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016), the Governor of Tamil Nadu, in consultation with the State Commissioner for Welfare of the Differently Abled, having regard to the nature of work in the Judicial Department, hereby exempts the Judicial Department in the State of Tamil Nadu from the provisions of clause (a) of the said sub-section (1) of section 34 in respect of reservation of appointment of persons with blindness and low vision to the posts belonging to Group 'C' and 'D' categories in that department, subject to the condition that the reservation of four percent under the said sub-section (1) of section 34 shall be allotted among the other categories of differently abled persons.
