Tamil Nadu Acts and Ordinances

The following Act of the Tamil Nadu Legislative Assembly received the assent of the Governor on the 22nd September 2021 and is hereby published for general information:-

ACT No.18 OF 2021.

An Act further to amend the Tamil Nadu Court-fees and Suits Valuation Act, 1955.

BE it enacted by the Legislative Assembly of the State of Tamil Nadu in the Seventy- second Year of the Republic of India as follows:-

1. (1) This Act may be called the Tamil Nadu Court-fees and Suits Short title and Valuation (Amendment) Act, 2021.

commencement.

Amendment of Schedule-I.

(2) It shall come into force at once.

2. In the Tamil Nadu Court-fees and Suits Valuation Act, 1955, in Schedule I, for the entries in columns (2) and (3) against Article 7 in column (1) thereof, the following entries shall, respectively, be substituted, namely:-

"Certificate under the Indian Succession Act, 1925.

Three per cent on the debt and security or the aggregate amount or value of the debts and securities specified in the Succession Certificate, subject to a maximum of twenty five thousand rupees.".
