ABSTRACT

Courts and Judges – Medical Reimbursement – Delegation of powers to the Principal District Judges of the Districts / Head of units and the Hon'ble Chief Justice of Madras High Court to sanction the Medical reimbursement claim of serving and retired Judicial Officers - Sanctioned – Orders – Issued.

ORDER:-

In the Government Order first read above, among others, orders have been issued in respect of medical facilities to the Judicial Officers both serving and retired and their family members as per the Shetty Commission recommendation on First National Judicial Pay Commission.

2. Further, in the Government Order second read above, amendment orders have been issued that the Principal District Judges are authorized to sanction medical reimbursement to serving as well as retired Judicial officers and for themselves upto Rs.50,000 and the Hon'ble Chief Justice of Madras High Court to sanction above Rs.50,000/- and upto Rs.1,00,000/- and above Rs.1,00,000/- in respect of serving and retired Judicial Officers shall be sent to Government for sanction.

3. The Registrar General, High Court of Madras in his D.O. letter third read above, has stated that keeping in view the fact that the limit for delegation of powers for sanctioning the medical reimbursement amount which may be exercised by the Principal District Judges and the Hon'ble The Chief Justice of the

High Court was fixed long ago and medical reimbursement claims have proportionately increased due to inflation or otherwise, the High Court reiterates its earlier proposal and requested the Government to enhance the limit to sanction the medical reimbursement to Rs.1,00,000/- to the Principal District Judges and Rs.5,00,000/- to the Hon'ble The Chief Justice of the Madras High Court and sanctioning of Medical Reimbursement Claim/bills above Rs. 5,00,000/- in respect of serving and retired Judicial Officers and their family members, to be made by the Government and requested to issue orders accordingly.

4. The Government, after careful examination have decided to accept it with suitable modification and accordingly sanction for delegation of powers to the Principal District Judges of the Districts/ Head of units and the Hon'ble Chief Justice of Madras High Court to sanction the medical reimbursement claim of serving and retired Judicial Officers as follows:
