



CIRCULAR

The Deputy Secretary to the Government of India, Ministry of Home Affairs (Public Section), New Delhi, vide letter dated 20.07.2022, has communicated the amendment made in Clause (xi) of paragraph 2.2 of Part – II of the Flag Code of India, 2002 as follows :

Existing Clause	Amended Clause
Clause (xi) of Paragraph 2.2 of Part-II of Flag code of India, 2002	Clause (xi) of paragraph 2.2 of Part-II of Flag code of India, 2002
(xi) where the Flag is displayed in open, it should, as far as possible, be flown from sunrise to sunset, irrespective of weather conditions;	(xi) Where the Flag is displayed in open or displayed on the house of a member of public, it may be flown day and night.

The aforesaid amendment is hereby circulated to all the Judicial Officers functioning in the State of Tamil Nadu and Union Territory of Puducherry, all the Officers and Staff of Madras High Court, and the Staff of the District Judiciary in the State of Tamil Nadu and Union Territory of Puducherry.
