The Accountant General, Tamil Nadu, in his letter second cited has requested to clarify whether the term 'leave' includes allkinds of leave including half-pay have and extraording leave and whether pay will be paid in full only in case where the nature of leave to be granted is not known or decided and the leave itself is pending sanction and whether the pay for the full month is to be paid only for the first month during the course of which the Government servant goes on leave and not for any subsequent

3. The Government in consultation of the Director of Treasuries and Accounts, Madras direct that --

i. the term'leave' includes all kinds of leave including half-pay leave;

ii. the pay willbe paid in full pending sanction of the laave, there is no need to know about the nature of the
