I am to invite a reference to the G.O. first cited  
and to state that the Government have issued Orders therein  
that the Government employees who have rendered 25 years of  
unblemished service under the State Government shall be  
awarded with an Indira Vikas Patra in the denomination of  
Rs.1,000/- (Rupees one thousand only) with an initial sale  
value of Rs.500/- (Rupees five hundred only).

I am also to state that a considerable number of  
unit officers have brought to the notice of the High Court  
that the sale of Indira Vikas Patra has been stopped by the  
postal Department and sought for clarifications from the  
High Court as to the alternative mode therefor.

I am further to state that the Government have informed the High Court that the award of incentive may be in the form of K.V.P. instead of I.V.P. to the Government servants who are eligible for the award as per the G.O. cited, when clarifications were sought for from the Government. The clarifications already issued by the Government in their letter No. 61131/CMPS/99-1, Finance (CMPC) Department, dated 14.09.99 in this regard <sup>is</sup> enclosed herewith for reference.

The receipt of this letter is required to be acknowledged immediately.
