C I R C U L A R

Sub: Courts and Judges-Conferment of powers on C.J.Ms - matters relating to 125 CrI.P.C. arising out of Head Quarters of each District- Certain instructions issuing of-Regarding.

* * *

It is now in force that all the matters under Chapter IX of the Criminal Procedure Code (Section 125 to 128 of the Code) where there is no territorial jurisdiction of a Family Court, are now dealt with the respective Judicial Magistrate(s) having the territorial jurisdiction concerned.

While conferring the powers and assigning of work to the Chief Judicial Magistrates; the High Court also consider the matter of assigning of additional work to the said Courts.

After due, deliberation and taking all other relevant matters into consideration the following instructions are issued:-

- (i) Where there is no territorial jurisdiction over to a Family Court, all the proceedings, in all the matters under Chapter IX of the Code of Criminal Procedure, 1973, (Section 125 to 128) arising out of the Head Quarters of each District alone, shall be filed before the Chief Judicial Magistrates concerned only and the Chief Judicial Magistrate shall take cognizance of the matter and dispose of the same in accordance to the provisions of Law/ Rules.

- (2) All such other proceedings pending before the Judicial Magistrate(s) in the Head Quarters, shall be transferred to the Court of Chief Judicial Magistrates as per the Provisions of Law/ Act laid down therefor and after giving prior intimation to the parties concerned.
